GLOBAL MARKETS HIGHLIGHTS

AUSTRALIA: Australian shares have lost ground on the first day of the new financial year as weakness in Asian markets, courtesy of weaker-than-expected Chinese manufacturing data, flowed into local sentiment. The benchmark S&P/ASX200 index closed 16.8 points, or 0.27 per cent, lower at 6,177.8 points.

NEW YORK: Wall Street's major stock indexes edged higher on Friday, as a surge in Nike shares helped the quarter close out on an upswing while concerns over US international trade relations ebbed. The Dow Jones Industrial Average rose 55.36 points, or 0.23%, to 24,271.41, the S&P 500 gained 2.06 points, or 0.08%, to 2,718.37 and the Nasdaq Composite added 6.62 points, or 0.09%, to 7,510.30.
